### **Our Itinerary At A Glance:**

**Day 1:** We begin our day with an early morning pick-up via our deluxe motorcoach. We will make a breakfast comfort stop as well as a lunch stop so that we can grab some food on our own as we make our way to Baltimore. Upon our arrival we will visit our first brewery - Guinness. Guinness brewery in Baltimore is located on the site of the first Maryland Distillery opened after prohibition. Since 1934, whiskey has been distilled, aged and blended right there. The building that contains the tap room, experimental brewery and barrel-house is one of four brick houses specifically constructed to age whiskey in oak barrels. They're just adding a new chapter for beer. As of August, 2018, they're making all new Guinness Blonde at the brewery in Maryland. In fact, the first thing the brewers did when they got the place up and running was to refine the Blonde recipe. Our tour here includes a walking tour of the facility followed by a wonderful sampling of Guinness beer. After some time to check into our hotel and freshen up for the evening we'll be heading out to Medieval Times dinner & show. Hang on to your helmet. The show is about to begin. Inside the stone wall of the 11<sup>th</sup> century-style castle, medieval Spain will come to life before your eyes. **EXPERIENCE**



a 4 course meal and select beverages included, a 2 hour medieval jousting tournament, 6 competing knights, Real weapons, Beautiful horses, and Live flight of the royal falcon. An incredible show for all to enjoy.

**Day 2:** We begin our day with our included breakfast at the hotel. We then depart for a fabulous day in Baltimore with our Exclusive "Tours and Pours" journey. We start the day with a stop at one of Baltimore's best local breweries, Heavy Seas, for a tour with tasting. Enjoy some free time in downtown Baltimore for lunch on our own followed by our tour of the City of Baltimore. Our journey includes the major sights of Baltimore and includes a stop at Sagamore Distillery. Here you'll learn about the famed history of Rye Whiskey in Maryland, see their 40-foot mirrored-finished copper column still, and taste three of their award-winning whiskies. This evening enjoy your included dinner at Gordon Biersch Brewery. Inspired by the Reinheitsgebot of 1516, the Gordon Biersch experience rests upon the foundations of purity, simplicity and precision. Their philosophy is most recognizable in the selection of authentic German lagers, each crafted on-site using only malted barley, hops, yeast and pure, filtered water. Enjoy a tour of the brewery with 2 beers included with your dinner specifically paired with your meal selection (wine for those that don't like beer). Then we're off to see the Patriots and Ravens battle it out for what is to be a key game towards the AFC Championship and another Super Bowl contention.

**Day 3:** This morning sleep in a bit after our day and evening in Baltimore. Then enjoy your included breakfast at the hotel. From here we will head north of the city to charming Chesapeake City. We will arrive at Chateau Bu De Winery. Born out of the love of fine wines and cheeses, Chateau Bu-De Winery & Vineyard has become the premiere location for fine wines. After traveling the world and sampling different wines, proprietors, Brenda & Warren Dedrick, decided to make their way back to the US and craft the finest wines on the Eastern Shore of Maryland. The family-owned vineyard & winery is located on 440 acres a top the Bohemia River in Chesapeake City, Maryland...the original site of Augustine Herrman's™ historical Bohemia Manor Farm™. Enjoy a tour of the vineyard and manufacturing facility, a sampling of wines, and your included luncheon overlooking the vineyard. A great way to culminate our trip before we make our way home with rest and dinner stops in route home. *Please note that this trip requires a moderate degree of walking due to the football game and tour schedule.
